## 1【提出理由】

当社は、当社の発行する新株予約権証券の本邦以外の地域における募集について、金融商品取引法第24条の5第4項及び第15項並びに企業内容等の開示に関する内閣府令第19条第1項及び第2項第1号の規定に基づき、以下のとおり本外国会社臨時報告書を提出する。

本募集は、当社及び当社の子会社の一定の従業員（以下「適格従業員」という。）に対して当社の修正改訂済2014年従業員株式購入制度（以下「本制度」という。）（購入期間：2023年7月1日から2023年9月30日まで）に従って付与される当社の記名式額面普通株式（以下「本株式」という。）を購入するオプション（以下「オプション」という。）に関するものである。本募集は、2021年6月25日付の当社取締役会による決議に従って行われるものである。

The preferred shares may also be redeemable at the option of the holder of the preferred shares or at the option of the

Company, and may be convertible into or exchangeable for shares of any other class or classes of the Company, depending on the terms of such preferred shares.

(Note 1) The number of stock acquisition rights and shares to be issued upon exercise of stock acquisition rights are calculated on the assumption that all the Eligible Employees as of the date hereof participate in the Plan, accumulate their payroll deductions to the maximum extent permitted under the Plan for three months and use such funds to purchase the Shares, and that the Shares will be issued at \$68.53 per share. This per share price is 85% of the estimated closing price of a Share on the New York Stock Exchange on September 29, 2023, which for these purposes is assumed to be the same as the closing price of \$80.62 on March 31, 2023. The actual number of stock acquisition rights and shares to be issued upon exercise of stock acquisition rights will be determined on September 29, 2023.

(Note 2) Total amount to be paid upon exercise of stock acquisition rights and the total amount of subscription payment are the estimate on the assumption that all the Eligible Employees as of the date hereof participate in the Plan, accumulate their payroll deductions to the maximum extent permitted under the Plan and use such funds to purchase the Shares, and that the Shares will be issued at \$68.53 per share, being 85% of the closing price of the Shares on the New York Stock Exchange on March 31, 2023 (\$80.62).

(Note 3) The amount to be paid upon exercise of stock acquisition rights and the price of shares to be issued upon exercise of stock acquisition rights are the estimate based on the assumption that the Shares will be issued at \$68.53 per share, being 85% of the closing price of the Shares on the New York Stock Exchange on March 31, 2023 (\$80.62). The actual amount to be paid upon exercise of stock acquisition rights and the price of shares to be issued will be 85% of the fair market value of the Shares on September 29, 2023. The term "fair market value of the Shares" is deemed to mean the closing price of the Shares on the New York Stock Exchange on the date of determination.
