Preferred shares may be preferred as to dividends, rights upon liquidation or voting in such manner as the directors of the Company may resolve. The preferred shares may also be redeemable at the option of the holder of the preferred shares or at the option of the Company, and may be convertible into or exchangeable for shares of any other class or classes of the Company, depending on the terms of such preferred shares.

(Note 1) The number of stock acquisition rights and shares to be issued upon exercise of stock acquisition rights are calculated on the assumption that all the Eligible Employees as of the date hereof participate in the Plan, accumulate their payroll deductions to the maximum extent permitted under the Plan for three months and use such funds to purchase the Shares, and that the Shares will be issued at \$67.90 per share. This per share price is 85% of the estimated closing price of a Share on the New York Stock Exchange on June 30, 2025, which for these purposes is assumed to be the same as the closing price of \$79.88 on December 31, 2024. The actual number of stock acquisition rights and shares to be issued upon exercise of stock acquisition rights will be determined on June 30, 2025.

(Note 2) Total amount to be paid upon exercise of stock acquisition rights and the total amount of subscription payment are the estimate on the assumption that all the Eligible Employees as of the date hereof participate in the Plan, accumulate their payroll deductions to the maximum extent permitted under the Plan and use such funds to purchase the Shares, and that the Shares will be issued at \$67.90 per share, being 85% of the closing price of the Shares on the New York Stock Exchange on December 31, 2024 (\$79.88).

(Note 3) The amount to be paid upon exercise of stock acquisition rights and the price of shares to be issued upon exercise of stock acquisition rights are the estimate based on the assumption that the Shares will be issued at \$67.90 per share, being 85% of the closing price of the Shares on the New York Stock Exchange on December 31, 2024 (\$79.88). The actual amount to be paid upon exercise of stock acquisition rights and the price of shares to be issued will be 85% of the fair market value of the Shares on June 30, 2025. The term "fair market value of the Shares" is deemed to mean the closing price of the Shares on the New York Stock Exchange on the date of determination.
